PROGRAMMING RECAP

Wellness Series

WIIIN would like to thank our community for growing with us as we expand our programming. As the pandemic has brought many changes to all our lives, with the help of Zoom, it gave WIIIN the opportunity to focus on health and personal development. We started the year with our wellness series "New Year, Lets Get Healthy Together", which included two events featuring certified Nutritionist Katie Bressack and Certified Aromatherapist, Jessica Klingbaum. On January 7, WIIIN members engaged with Katie Bressack to discover how sugar, stress and lack of sleep affecting your health. The discussion was focused on simple yet effective steps we can take to increase energy levels, maintain a more balanced mood, reduce cravings and think more clearly. On February 10, WIIIN members engaged with Jessica Klingbaum, for a fun, informative and interactive workshop, focused on essential oils and aromatherapy. WIIIN thanks Katie and Jessica for their participation, as we received very positive feedback from our members on both sessions, and will continue to pursue healthfocused events for our members going forward. Career Series

WIIIN offered a 3-part career series in the Spring in collaboration with Inside Out Incubator and Career Coach, Tracy Podell. Alicia Jabbar and Gina Restani from Inside Out kicked off the series with an hour and a half session entitled "How to Break the Rules and Level Up Your Career" teasing out the norms we ascribe to without scrutiny and challenging us to break free from those that do not serve us. The second session was "Quieting the Voice of your Inner Critic" where participants found a safe space to acknowledge their own saboteur and found strength and ideas from the group on how to disengage their negative voice. In the last session, Tracy Podell worked members through a very practical and immediately actionable 5-year career planning framework. Private Markets & the Pandemic: Impact and Implications

On April 22, WIIIN held our second flagship event of 2021, focused on Private Markets and the Pandemic. The event took place on the Remo platform and featured and interactive panel of four influential women: Mary Bates (Meketa), Robin Potts (Canyon Partners), Tanya Kemp (SFERS) and (moderated by) Esme del Bosque (LACERA). The discussion focused on how the global pandemic has impacted the private market investment landscape and was followed by virtual networking. We thank Mary, Robin, Tanya and Esme for their expertise and participation. The event was well received by the community and the discussion relevant and timely.

Annual Luncheon: Listening Louder, Creating an Inclusive Company Culture

WIIIN held our fifth Annual (Virtual) Luncheon on June 23 using the Remo platform, a fire-side chat focused on creating an inclusive company culture. The discussion featured Shelly Heier (President, Senior Consultant and Leader of the Institutional Investing Diversity Cooperative at Verus Investments and Susan Long-Walsh (Senior Practice Leader, DE&I Initiatives T-Mobile and a Coach and Talent Recruiter for top corporations). Together they covered a wide-range of topics on inclusive behavior in the work place, focused on race, disability, gender and sexual identity. WIIIN was thrilled to honor Betsy Berkhemer-Credaire, Chief Executive Officer, 50/50 Women on Boards for her tireless work on advocating for women and

accelerating gender balance and diversity on corporate boards. WIIIN thanks the over 240 attendees who participated and our sponsors and members for your continued support. Our FIFTH Annual Luncheon is a milestone for the organization and we are grateful to celebrate with our community.
